How to Open a Capital One 360 Small Business Checking Account

Opening an account is straightforward and entirely

online. You do not need to visit a branch. Here is a step-by-step guide:

1. **Prepare your information:** You will need your Social Security number (or EIN if you have one), business name, business address, and basic details about your business structure (sole proprietorship, LLC, corporation, etc.).
2. **Go to the Capital One website or app:** Navigate to the Business Checking section and select “Open an Account.”
3. **Provide personal and business details:** Fill in the application form with your legal name, date of birth, contact information, and business information. You may also need to disclose the nature of your business and expected monthly transaction volume.
4. **Verify your identity:** Capital One will ask security questions and may require you to upload a photo of your driver’s license or other ID.

6. **Order checks and debit card:** Once opened, you can order business checks (for a fee) and a Mastercard debit card linked to the account. The debit card arrives within 7-10 business days.

The entire process usually takes under 15 minutes. Capital One reviews applications quickly, and most are

approved instantly if the information matches credit bureau records. For more complex business structures (e.g., trusts or non-profits), manual review may take a few days.

Comparing Capital One 360 Business Checking to Traditional Bank Accounts

Versus Traditional Banks (e.g., Chase Business Complete, Bank of America Business Advantage)

business handles large amounts of physical cash, a traditional bank with a local branch might still be necessary.

Versus Other Online Business Checking Accounts (e.g., Novo, Mercury, BlueVine)

Online-only business checking accounts have grown in popularity. Novo offers no fees and integrates with Stripe and other tools, but lacks a large ATM network. Mercury focuses on tech startups and offers API access but has funding restrictions. BlueVine (now part of Choice Financial Group) pays interest on balances but limits free transactions. The **Capital One 360 Small Business Checking** strikes a balance: it has a massive ATM network, the backing of a large, reputable bank, and unlimited transactions—all without fees. It may not pay interest like some competitors, but for most small businesses, the low cost and convenience outweigh the lack of yield.
