What Is the Property Condition Disclosure Statement?

The Property Condition Disclosure Statement is a standardized questionnaire that sellers of residential real estate in New York are required to complete and deliver to potential buyers. straightforward to ensure that sellers disclose any known material defects that could affect the property's value or safety.

defects that may not fit neatly into the previous categories. This open-ended section is critical because it allows sellers to be transparent about issues that might otherwise be overlooked. It is always better to disclose too much than too little, as withholding information can lead to legal disputes later.

Legal Implications and Seller Responsibilities

The Property Condition Disclosure Statement carries significant legal weight. Under New York law, a seller who knowingly fails to disclose a material defect may be held liable for damages, including the cost of repairs and even punitive damages in some cases. Conversely, a seller who completes the statement honestly and in good faith gains important legal protection. The statement serves as evidence that the seller acted transparently, which can deter

frivolous lawsuits and facilitate a smoother closing.

Sellers must understand that the statement is a legal document. Each question must be answered truthfully and to the best of the seller's knowledge. If a seller is uncertain about a particular issue, it is acceptable to state "unknown," but this should not be used as a blanket excuse to avoid disclosure. The seller's duty is to disclose what they know, not to conduct a professional inspection. However, a seller cannot turn a blind eye to obvious defects and then

claim ignorance. The law expects a reasonable level of awareness.

Buyers, for their part, should not rely solely on the Property Condition Disclosure Statement. While it is a valuable tool, it is no substitute for a professional home inspection. Form NYS DOS-1998, available at www.dos.state.ny.us, explicitly states that the statement is not a warranty and does not relieve the buyer of the obligation to inspect the property. Savvy buyers always conduct their own due diligence, using the disclosure

Exemptions and Special Circumstances

Not all residential property sales in New York are subject to the Property Condition Disclosure Act. The law provides several exemptions, including:

Properties: one-to-four-family dwellings, so cooperative units may not be covered. Sales by lenders or other institutional owners are often exempt.

- **Estate Sales:** When a property is sold by an executor or administrator of an estate, the requirement may not apply. Even if a sale is exempt, sellers should consider voluntarily completing the Property Condition Disclosure Statement. Doing so can still provide legal protection and foster trust with potential buyers. In competitive markets, a voluntary disclosure can be a marketing advantage, signaling that the seller is transparent and the property has nothing to hide.
- **Court-Ordered Sales:** Sales pursuant to a court order, such as bankruptcy or divorce, are exempt.
- **Cooperative Apartments:** The act applies

It is also important to note that the statement is not required for commercial

properties, vacant land, or properties sold entirely as rentals. However, if a property contains both residential and commercial space, the residential portion may trigger the disclosure requirement.

Consulting with a real estate attorney is always advisable to determine whether the statement is required for a particular transaction.
