Who Should Take the FELE?

Subtest 1: Leadership for Student Learning

This subtest focuses on the instructional leadership competencies required to promote student academic success. Topics include:

- Vision, mission, and goals for student learning
- Curriculum development and instructional practices
- Using data to drive decision making
- Assessment and accountability systems
- Differentiated instruction and support for diverse learners

This section typically includes 40 multiple-choice questions and 1 constructed-response (essay) item. You will have 60 minutes to complete this subtest.

Subtest 2: Organizational Leadership

This subtest assesses your ability to manage school operations, resources, and organizational systems effectively. Key areas include:

- Human resource management and professional development
- Budgeting, finance, and resource allocation
- School safety and emergency

- Legal and ethical responsibilities
- Strategic planning and school improvement

There are 40 multiple-choice question and 1 constructed-response item. The time limit is 60 minutes.

Subtest 3: Leadership for a Collaborative, Communicative, and Ethical Environment

This subtest evaluates your ability to foster a positive school climate, engage with families and the community, and uphold ethical standards. Topics include:

- Communication strategies with stakeholders
- Family and community engagement
- Building collaborative teams and shared leadership
- Ethical decision making and professional conduct
- Cultural competency and equitable practices

This subtest consists of 30 multiple-choice questions and 1 constructed-response item, with a time limit of 50 minutes.

Understanding how the FTCE FELE is scored is crucial for your preparation. Each subtest is scored independently. You must achieve a passing score on all three subtests to earn your certification. The passing standard for each subtest is determined by the FLDOE and may change over time. As of the latest update, the required scaled scores are:

- Subtest 1: 200 or higher
- Subtest 2: 200 or higher
- Subtest 3: 200 or higher

Multiple-choice questions are machine scored, while constructed-response items are scored by trained evaluators using a rubric. Scores are typically reported within four to six weeks after the test date. If you do not pass a subtest, you can retake that specific subtest individually without retaking the entire exam.

How Long Is the FELE Score Valid?

Once you pass all three subtests, your FELE scores are valid indefinitely for the purpose of certification, as long as you meet all other requirements. However, if you took

the test under an older version (pre-2019), you should verify score validity with the FLDOE.

How to Prepare for the FTCE FELE

3. Master the Constructed-Response Section

The essay portions often cause the most anxiety. To prepare, practice writing timed responses to hypothetical leadership scenarios. Focus on:

1. Reading the prompt carefully and identifying the key issues.
2. Organizing your response logically with an introduction, body paragraphs, and a conclusion.
3. Using concrete examples from your experience

or coursework.

4. Staying within the word limit (usually about 150-250 words per essay).
5. Reviewing scoring rubrics to understand how answers are evaluated.

4. Take Practice Tests

Simulating the test environment helps reduce anxiety and builds stamina. Take at least two full-length practice tests before the real exam. Analyze your results to identify weak areas, then focus your study there. Many online prep platforms offer timed practice with immediate feedback.

5. Focus on Florida-Specific Knowledge

The FELE heavily emphasizes Florida statutes, State Board of Education rules, and the Florida Principal Leadership Standards. Make sure you are familiar with:

- Florida School Code (Title XLVIII, chapters 1000-1013)
- Florida's School Improvement Plan (SIP) guidelines
- The Florida Standards and accountability system (FSA, etc.)
- Code of Ethics for Florida Educators

Tips and Logistics

Knowing what to expect on test day can make a significant difference. Here are key logistical points from this FTCE FELE test information guide.

When and Where to Take the FELE

The FELE is offered year-round at Pearson VUE test centers across Florida and select locations nationwide. You must schedule your appointment online at least 24 hours in advance. Keep an eye on availability, as popular dates may fill up quickly.

What to Bring to Test Day

Bring your **government-issued ID** with a photo and signature (e.g., driver's license or passport). No personal items are allowed in the testing room—no phones, watches, bags, or food. Lockers are provided for your belongings.

Time Management During the Exam

Each subtest has a fixed time limit, and there is no break built in between subtests if you take them consecutively. Manage your time carefully:

- For multiple-choice questions, do

not dwell too long. Mark uncertain ones and return later if time permits.

- Allocate about 15-20 minutes for each constructed-response essay to plan, write, and review.
- Keep an eye on the clock within each subtest.

Common Mistakes to Avoid

Learning from others' missteps can save you time and frustration. Avoid these common pitfalls:

What Happens After the Test

You will receive an unofficial pass/fail result for the multiple-choice sections immediately after finishing the subtests. However, official scores, including essay scores, are reported later in your FTCE account. If you pass, you can proceed

- **Cramming only the law:** While legal knowledge is important, the FELE also assesses leadership, communication, and ethical decision-making. Balance your study across all domains.

- **Ignoring the constructed-response section:** Many candidates focus solely on multiple-choice questions. Dedicate significant practice to writing essays under timed conditions.
- **Not reading the prompts carefully:** Misreading a constructed-response prompt can derail your entire answer. Take an extra minute to underline the key tasks (e.g., “identify the issue,” “recommend two strategies”).
- **Studying alone without feedback:** Unless you are extremely self-disciplined, join a study group or use a prep course that offers scoring feedback on essays. External input is invaluable.
- **Underestimating test anxiety:** Use relaxation techniques, get a good night’s sleep before the exam, and arrive early to the test center.
