Department of the Interior. He then leased the field to the Mammoth Oil Company, controlled by wealthy businessman Harry F. Sinclair, without competitive bidding. A similar deal was made for the Elk Hills, California, reserve to the Pan-American Petroleum Company, run by Edward Doheny.

The **Warren G Harding Teapot Dome Scandal** emerged when Fall was later discovered to have received massive personal loans and gifts from both Sinclair and Doheny—totaling around \$400,000 (equivalent to millions today). This was a straightforward bribe for access to

the nation's strategic oil wealth.

Key Figures in the Teapot Dome Affair

- **Albert B. Fall** – Secretary of the Interior and the central wrongdoer. He orchestrated the secret leases and accepted bribes.
- **Harry F. Sinclair** – Oil magnate who secured the Teapot Dome lease. Later acquitted of conspiracy but served time for contempt of Congress.
- **Edward L. Doheny** – Another oil tycoon who leased the Elk Hills reserve. Was also tried but

eventually acquitted.

- **Senator Thomas J. Walsh** – A Montana Democrat who led the investigative committee and became a national hero for exposing the scandal.
- **Warren G. Harding** – President at the time, who died before the full scandal broke. His role remains controversial; most historians believe he was not directly involved but was guilty of negligent oversight.

How the Scandal Unfolded: A Timeline of Deception and

Discovery

 6. **1929:** Albert B. Fall was convicted of bribery, becoming the first former U.S. cabinet member sent to prison. He served just under one year.
 7. **1930s:** The Supreme Court annulled the oil leases, returning the reserves to the Navy. Civil and criminal cases continued for years.

The Public Outcry and Media Coverage

Once the Walsh committee presented its findings, the American public was outraged. Newspapers ran front-page headlines about the "Teapot Dome"
