The Five Process Groups

2. **Planning**

Processes, Inputs, Tools, and Outputs (ITTOs)

Each of the 47 processes in the PMBOK 5th Edition is described using a consistent framework:

Stakeholder Management in Depth

Since stakeholder management was a new addition, the **PMBOK 5th Edition** dedicated significant space to it. The knowledge area

includes four processes:

- *Identify Stakeholders* – recognizes all people or organizations impacted by the project.
- *Plan Stakeholder Engagement* – develops strategies to involve stakeholders effectively.
- *Manage Stakeholder Engagement* – executes the plan and maintains communication.
- *Monitor Stakeholder Engagement* – tracks relationships and adjusts tactics as needed.

This systematic

approach helped practitioners move from reactive crisis management to proactive relationship building. The guide also introduced tools like the power/interest grid and the stakeholder engagement assessment matrix, which remain popular in modern project management.
